DEFINITIONS

- 1. For the purposes of this Confidentiality Order:
 - a. "Disputing Party" means either Resolute Forest Products Inc. or the Government of Canada;
 - b. "Confidential Information" means information that is not publicly available and is designated by a Disputing Party as confidential on the grounds that it is:
 - i. Business Confidential Information of a Disputing Party or of a provincial, territorial or municipal government;
 - ii. Business Confidential Information relating to a third party;
 - iii. information otherwise protected from disclosure under the applicable domestic law of the disputing State party including, but not limited to, and as amended, Canada's Access to Information Act, the Canada Evidence Act, Canada's Privacy Act, and Nova Scotia's Freedom of Information and Protection of Privacy Act; or
 - iv. information that is deemed to be financial, commercial, scientific or technical information supplied by third parties that has been treated as Confidential Information by those third parties;
 - c. "Business Confidential Information" includes:
 - i. trade secrets;
 - ii. financial, commercial, scientific or technical information that is treated consistently in a confidential manner by the Disputing Party, provincial, territorial or municipal government or third party to which it relates, including pricing and costing information, marketing and strategic planning documents, market share data, or detailed accounting or financial records not otherwise disclosed in the public domain;
 - iii. information the disclosure of which could result in material financial loss or gain to the Disputing Party, provincial, territorial or municipal government or third party to which it relates;
 - iv. information the disclosure of which could interfere with contractual or other negotiations of the Disputing Party, provincial, territorial or municipal government or third party to which it relates; or
 - v. other communications treated as confidential in furtherance of settlement between the Disputing Parties.
 - d. "Restricted Access Information" means Confidential Information within the meaning of paragraph 1(b) that is designated by a Disputing Party as restricted access on the grounds that:
 - the disclosure of this information to the other Disputing Party could result in a serious material gain or loss which could potentially prejudice the competitive position of the Disputing Party, provincial, territorial or municipal government or third party to whom that information relates; or

- ii. the information is highly sensitive Business Confidential Information that belongs or relates to a Disputing Party, provincial, territorial or municipal government or third party.
- e. "Written Submission" includes a brief, memorial, witness statement, exhibit or expert report.
- f. "Public Document" means a Written Submission, transcript, order or award that contains no Restricted Access Information or Confidential Information and no redactions of such information.
- g. "Public Version" means the version of a Written Submission, transcript, order or award that has been redacted to remove all Restricted Access Information and Confidential Information.
- h. "Restricted Access Version" means the version of a Written Submission, transcript, order or award that contains Restricted Access Information and Confidential Information that has not been redacted.
- i. "Confidential Version" means the version of a Written Submission, transcript, order or award that contains Confidential Information that has not been redacted and contains no Restricted Access Information or has been redacted to remove all Restricted Access Information.

OBJECTIVE/PURPOSE

- 2. The Disputing Parties agree to respect and maintain the confidentiality of information exchanged in this arbitration in accordance with the terms of this Confidentiality Order.
- 3. A Disputing Party may designate Confidential or Restricted Access Information contained in any document that the Disputing Party produces to the other Disputing Party, and in any Written Submission, transcript, order or award. These designations shall be made in accordance with the procedures set out in this Confidentiality Order.
- A Disputing Party shall not designate as Restricted Access Information any information belonging to the other Disputing Party which that Disputing Party has not also designated as Restricted Access Information.

DOCUMENTS EXCHANGED IN DOCUMENT PRODUCTION

- 5. A document produced by a Disputing Party to the other Disputing Party shall be protected from disclosure as though it contained Confidential Information in its entirety, except that (a) should the document be filed by one of the Disputing Parties as part of a Written Submission, the Disputing Parties must follow the process for designating Confidential Information as set out in this Confidentiality Order; and (b) any produced documents that are already publicly available need not be treated as Confidential Information protected from disclosure.
- 6. If a Disputing Party contends that a document that it produces to the other Disputing Party contains Restricted Access Information, the Disputing Party shall provide its proposed designations of Restricted Access Information by clearly labelling each page of the document as "Restricted Access" at the time that it produces the document. A document produced by a Disputing Party to the other Disputing Party containing such

proposed designations shall be deemed to constitute Restricted Access Information in its entirety unless an objection is filed under paragraph 7 or the document is filed by one of the Disputing Parties as part of a Written Submission, in which case the Disputing Parties shall follow the process for designating Restricted Access Information as set out in this Confidentiality Order.

7. A Disputing Party may object to a proposed designation of Restricted Access Information in a document that it obtains through the other Disputing Party's Document Production. If such an objection is made, the Disputing Parties shall attempt to agree on the final designations of Restricted Access Information in the document. If the Disputing Parties do not agree on the final designations of Restricted Access Information, a Disputing Party may submit the objection to the Tribunal for resolution. The Tribunal may invite further submissions on proposed designations of Restricted Access Information.

WRITTEN SUBMISSIONS

Restricted Access Information Filings

- 8. A Disputing Party shall provide, at the time that it files a Written Submission, a preliminary Restricted Access Version of the Written Submission containing its proposed designations of Restricted Access Information, if any, of the Disputing Party making the filing. A Disputing Party shall provide, at the time it files the exhibits to a Written Submission, a preliminary Restricted Access Version of those exhibits containing the proposed designations of Restricted Access Information, if any, of the Disputing Party making the filing. Double brackets ([[]]) or highlighting shall be used to surround designated Restricted Information.
- 9. A Disputing Party shall have fourteen (14) calendar days from the date of receiving a Written Submission from the other Disputing Party (and therefore, seven (7) calendar days of the date that exhibits forming part of its Written Submission are filed under paragraph 8.2 of Procedural Order No. 1), to object to any proposed designations of Restricted Access Information and to provide its own further proposed designations of Restricted Access Information, if any, in the Written Submission and its accompanying exhibits.
- 10. If such objections or further proposed designations are provided, the Disputing Parties shall attempt to agree on the final designations of Restricted Access Information in the Written Submission. If the Disputing Parties do not agree on the final designations of Restricted Access Information, a Disputing Party may submit any outstanding objections to the Tribunal for resolution. The Tribunal may invite further submissions on proposed designations of Restricted Access Information.

Confidential Information Filings

11. A Disputing Party shall provide, within fourteen (14) calendar days from the date that exhibits forming part of a Written Submission are filed under paragraph 8.2 of Procedural Order No. 1, a preliminary Confidential Version of the Written Submission and its exhibits containing the proposed designations of Confidential Information in the Written Submission and exhibits, if any, of the Disputing Party making the filing. Single brackets ([]) or highlighting shall be used to surround designated Confidential Information.

- 12. A Disputing Party shall have fourteen calendar days from the date of receiving the other Disputing Party's proposed designations of Confidential Information in a Written Submission to object to those proposed designations and to provide its own further proposed designations of Confidential Information, if any, in the Written Submission.
- 13. If such objections or further proposed designations are provided, the Disputing Parties shall attempt to agree on the final designations of Confidential Information in the Written Submission. If the Disputing Parties do not agree on the final designations of Confidential Information, a Disputing Party may submit any outstanding objections to the Tribunal for resolution. The Tribunal may invite further submissions on proposed designations of Confidential Information.

All Filings

- 14. Within ten (10) calendar days from the date on which the final designations of Confidential and Restricted Access Information have been confirmed by agreement of the Disputing Parties, by the failure of a Disputing Party to make or object to any designation, or by order of the Tribunal, the Disputing Party that originally filed the Written Submission shall file:
 - a. a final Restricted Access Version of the Written Submission reflecting the final designations of Restricted Access and Confidential Information;
 - a final Confidential Version of the Written Submission reflecting the final designations of Confidential Information but with all Restricted Access Information redacted; and
 - a final Public Version of the Written Submission, with all Confidential and Restricted Access Information redacted.
- 15. Each page of a Restricted Access Version must be labeled "Restricted Access, Unauthorized Disclosure Prohibited". Each page of a Confidential Version must be labeled, "Confidential Information, Unauthorized Disclosure Prohibited." Each page of a Public Version must be labeled "Public Version." Public Documents shall be labeled "Public Document" on the first page of the document.
- 16. Where whole documents or multiple pages of Restricted Access Versions or Confidential Versions have been redacted entirely, such pages need not be reproduced in redacted form in the Public Version. Instead, a summary page stating the number of pages that have been redacted in their entirety will suffice.
- 17. A procedural timetable for Restricted Access and Confidential Information designations in Written Submissions is provided in Schedule 1 of this Confidentiality Order.

TRANSCRIPTS, ORDERS, AWARDS

18. The Disputing Parties shall have ten (10) calendar days from the receipt of a transcript or order to designate information as Confidential or Restricted Access Information in the transcript or order and to exchange such designations. The Disputing Parties shall have an additional ten (10) calendar days from the receipt of such designations to raise any objections to the other Disputing Party's designations. At the conclusion of that period,

if the Disputing Parties are unable within fourteen (14) calendar days to agree on any designations of Confidential or Restricted Access Information, a Disputing Party may submit the issues to the Tribunal for resolution.

- 19. If the Tribunal's award discloses Confidential or Restricted Access Information, the Tribunal shall issue the following versions of the award, as applicable:
 - a. a Restricted Access Version of the award;
 - b. a Confidential Version of the award with all Restricted Access Information redacted; and
 - c. a Public Version of the award, with all Confidential and Restricted Access Information redacted.
- 20. The Disputing Parties shall have thirty (30) calendar days from the receipt of an award to designate information as Confidential or Restricted Access Information in the award and to exchange such designations. The Disputing Parties shall have an additional ten (10) calendar days from the receipt of such designations to raise any objections to the other Disputing Party's designations. At the conclusion of that period, if the Disputing Parties are unable within fourteen (14) calendar days to agree on any designations of Confidential or Restricted Access Information, a Disputing Party may submit the issues to the Tribunal for resolution.
- 21. Within ten (10) calendar days after any objections to proposed designations of Confidential or Restricted Access Information have been resolved by agreement of the Disputing Parties or by order of the Tribunal, the Disputing Parties shall consolidate their final designations and file with the Tribunal, as appropriate, a final Restricted Access Version, Confidential Version, and Public Version of the transcript, order or award.
- 22. A procedural timetable for Restricted Access and Confidential Information designations in transcripts, orders and awards is provided in Schedule 2 of this Confidentiality Order.

TREATMENT OF RESTRICTED ACCESS AND CONFIDENTIAL INFORMATION

- 23. Until the elapse of any period for a Disputing Party to provide the other Disputing Party with its proposed designations of Restricted Access Information therein, or such earlier time should the Disputing Parties communicate in writing that they have no proposed designations or requests for changes of bracketed information, a Written Submission (including exhibits), transcript, order or award, shall be deemed to be designated as Restricted Access. Thereafter, until the final designations of Restricted Access Information have been agreed by the Disputing Parties, or determined by the Tribunal, each Disputing Party's proposed designations of Restricted Access Information shall be presumed valid. For greater certainty, the Disputing Parties and the Tribunal shall not disclose the Written Submission (including exhibits), transcript, order or award to any person not authorized to receive Restricted Access Information under the terms of this Confidentiality Order until any Restricted Access Information has been designated in accordance with the terms of this Confidentiality Order.
- 24. Until the elapse of any period for a Disputing Party to provide the other Disputing Party with its proposed designations of Confidential Information therein, or such earlier time should the Disputing Parties communicate in writing that they have no proposed designations or requests for changes of bracketed information, a Written Submission

(including exhibits), transcript, order or award shall be deemed to be designated as Confidential. Thereafter, until the final designations of Confidential Information have been confirmed by agreement of the Disputing Parties, by the failure of a Disputing Party to make or object to any designation, or by order of the Tribunal, each Disputing Party's proposed designations of Confidential Information shall be presumed valid. For greater certainty, the Disputing Parties and the Tribunal shall not disclose the Written Submission (including exhibits), transcript, order or award to any person not authorized to receive Confidential Information under the terms of this Confidentiality Order until the Confidential Information has been designated in accordance with the terms of this Confidentiality Order.

- 25. Materials already exchanged by the Disputing Parties before the execution of this Confidentiality Order can be designated as confidential by notifying the other Disputing Party of such designation within ten (10) calendar days from the execution of this Confidentiality Order. Restricted Access, Confidential, and Public Versions of the materials shall also be provided to the other Disputing Party, as appropriate.
- 26. The time periods set out in this Confidentiality Order may be amended by agreement of the Disputing Parties, or by order of the Tribunal after hearing the Disputing Parties and taking into account all relevant circumstances.
- 27. Except with the prior written consent of the Disputing Party that claimed confidentiality with respect to the information, and, in the case of materials from provincial, territorial or municipal governments or third parties, the owner of such Confidential Information, Confidential Information may be used only in these proceedings and may be disclosed only for such purposes to and among:
 - Members of the Tribunal (and their assistants, if any) and officials of the Permanent Court of Arbitration (the "Registry") to whom disclosure is reasonably considered by one or more Members of the Tribunal to be necessary;
 - b. counsel to a Disputing Party (and their support staff) or counsel to provincial, territorial or municipal governments whose involvement in the preparation or conduct of these proceedings is reasonably considered by a Disputing Party to be necessary in connection with preparation of the Disputing Party's case;
 - officials or employees of the Disputing Parties or of provincial, territorial, or municipal governments to whom disclosure is reasonably considered by the Disputing Party to be necessary in connection with preparation of the Disputing Party's case;
 - d. independent experts or consultants retained or consulted by the Disputing Parties or by provincial, territorial, or municipal governments in connection with these proceedings;
 - e. witnesses, who in good faith are reasonably expected by a Disputing Party to offer evidence in these proceedings but only to the extent material to their expected testimony; or
 - f. court reporters and other hearing support staff.
- 28. Except with the prior written consent of the Disputing Party that claimed confidentiality with respect to the information, and, in the case of materials from provincial, territorial or municipal governments or third parties, the owner of such Restricted Access Information,

Restricted Access Information may be used only in these proceedings and may be disclosed only to and among the following people, where their access to the information is necessary for the preparation of the conduct of the case:

- Members of the Tribunal (and their assistants, if any) and officials of the Registry to whom disclosure is reasonably considered by one or more Members of the Tribunal to be necessary;
- b. counsel to a Disputing Party (and their support staff) and counsel to provincial, territorial or municipal governments. Counsel to the Claimant who are also officials or employees of the Claimant shall not have access to Restricted Access Information:
- c. independent experts or consultants retained or consulted by the Disputing Parties: or
- d. court reporters and other hearing support staff.
- 29. No Disputing Party shall file any confidential material covered by the terms of this Confidentiality Order in any Court without first bringing this Confidentiality Order to the attention of the Court and seeking directions concerning the filing of such material in a manner that protects its confidentiality. A Disputing Party shall notify the other Disputing Party and any affected parties prior to requesting such direction from the Court.
- 30. Inadvertent or improper disclosure of Confidential Information, as set forth in the present Order, does not constitute a waiver of the designation of the information as confidential.
- 31. All persons receiving Confidential Information or Restricted Access Information shall be bound by this Confidentiality Order. Each Disputing Party shall have the obligation of notifying all persons receiving Confidential Information or Restricted Access Information of the obligations under this Confidentiality Order and to ensure that such persons receiving Confidential Information pursuant to paragraphs 27(d) or (e) or Restricted Access Information pursuant to paragraph 28(c) execute a Confidentiality Undertaking in the form attached as Appendix A, or a Restricted Access Information Confidentiality Undertaking in the form attached as Appendix B, as appropriate, before gaining access to any such information. Each Disputing Party shall maintain copies of Confidentiality Undertakings under Appendix A and shall make such copies available to the other Disputing Party upon order of the Tribunal or upon the termination of this arbitration. Each Disputing Party shall maintain copies of Restricted Access Information Confidentiality Undertakings and shall make such copies available to the other Disputing Party two (2) business days before the person signing the Restricted Access Information Confidentiality Undertaking gains access to any Restricted Access Information.
- 32. Where Confidential Information is used or discussed at any hearing, the following rules shall apply:
 - a. the Tribunal shall restrict access to that portion of the hearing only to: (i) authorized persons in accordance with the terms of this Order; and (ii) originators of the Confidential or Restricted Access Information; and
 - b. transcripts of those portions of the hearing in which Confidential Information and Restricted Access Information is used or discussed shall not be made public.

- 33. Notwithstanding any other provision in this Confidentiality Order, any request for documents, or for the production of documents under the applicable domestic law of the disputing State party, including documents produced to Canada in these proceedings, shall be wholly governed by the relevant legislation.
- 34. In the light of the Note of Interpretation of the NAFTA Free Trade Commission issued July 31, 2001, which is binding upon the Tribunal pursuant to Article 1131(2) of the NAFTA, a Disputing Party shall be free to disclose to the public Public Documents and the redacted, Public Versions of Written Submissions of the Disputing Parties, including the Notice of Arbitration, and decisions of the Tribunal, correspondence to or from the Tribunal, transcripts of hearings, procedural rulings and orders and awards.
- 35. Notwithstanding any other provision in this Confidentiality Order, the Disputing Parties may make such disclosure of documents or information as is required by law.
- 36. In accordance with Articles 1127, 1128 and 1129 of the NAFTA, non-disputing NAFTA Parties may attend the portions of oral hearings which are not held *in camera*, and have access to Public Versions of transcripts, orders, awards and Written Submissions.
- 37. Nothing in this Confidentiality Order shall be construed to abrogate or support a claim or entitlement with respect to a refusal to disclose any information on the basis of a privilege, ground for exemption or non-disclosure or public interest immunity arising at common law, or under national or provincial legislation.
- 38. One (1) unredacted copy of transcripts, orders, awards and Written Submissions, including those designated as Restricted Access and Confidential Information under this Order, may be retained by the Disputing Parties' legal counsel identified in paragraph 28(b). Any other documentation which has not been designated as a Public Document or Public Version must be returned to the respective Disputing Party or otherwise destroyed within thirty (30) calendar days following the later of: the conclusion of any set aside proceedings; the time to request set aside proceedings under Article 1136 of the NAFTA has expired; or the full compliance of a Disputing Party with the Tribunal's Final Award. When a Disputing Party destroys documentation, the Disputing Party shall provide a written certification of destruction of the documents to the other Disputing Party.
- The obligations created by this Order shall survive the termination of these proceedings.
- 40. This Confidentiality Order shall be effective and binding upon a Disputing Party upon the signature of the Confidentiality Order by the Tribunal.
- 41. A Disputing Party may apply for an amendment to, or a derogation from, this order if compelling circumstances so require.
