Procedural Order No. 22

I. PROCEDURE

- 1. <u>On 26 August 2016</u>, the Tribunal issued *Procedural Order No. 1* ("PO 1") on the procedure of the present arbitration.
- 2. <u>On 10 January 2017</u>, the Tribunal adopted the Procedural Calendar, issued as Annex A to *Procedural Order No. 4* ("PO 4").

This Procedural Calendar has been amended twice by the Parties. First, by their respective letters of $\underline{7}$ and $\underline{13}$ of February 2018, and more recently, by their $\underline{11}$ April 2018 communications. These amendments have not be confirmed by the Tribunal.

- 3. <u>On 7 February 2018</u>, Teresa Cheng (the then President of the Tribunal) resigned.
- 4. <u>On 5 April 2018</u>, Prof. Pierre Tercier was appointed as President of the Tribunal.
- 5. <u>On 27 April 2018</u>, the Parties communicated their joint proposals on the Procedural Calendar.
- 6. <u>On 8 May 2018</u>, the Tribunal asked the Parties to reserve the weeks of 2 and 9 December 2019 for the hearing. Both Parties confirmed their availabilities and the Tribunal acknowledged such confirmation <u>on 18 May 2018</u>.
- 7. <u>On 29 May 2018</u>, the Tribunal and the Parties held a conference call, during which they discussed several items, including the confirmation of the amendments to the Procedural Calendar as proposed <u>on 27 April 2018</u> by the Parties.
- 8. <u>On 5 June 2018</u>, the Tribunal issued *Procedural Order No. 9* ("PO 9") adopting the amended Procedural Calendar of the present arbitration.
- 9. <u>On 18 and 19 October 2018</u>, the Parties communicated an agreed amendment to the Procedural Calendar to the Tribunal.
- 10. <u>On 5 June 2018</u>, the Tribunal issued *Procedural Order No. 18* ("PO 18") adopting the further amended Procedural Calendar of the present arbitration.
- 11. <u>On 13 December 2018</u>, Claimants requested an extension until 28 February 2019 to file their comments on the Non-Disputing Parties' Submission. These comments were due, simultaneously with those of Respondent, on 18 January 2019.
- 12. <u>On 26 December 2018</u>, and following relevant correspondence from Respondent and the Tribunal, Respondent accepted Claimants' request for extension.
- 13. <u>On 27 December 2018</u>, the extension was confirmed by the Tribunal.
- 14. <u>On 3 January 2019</u>, the Tribunal issued *Procedural Order No. 21* ("PO 21") adopting the further amended Procedural Calendar in the present arbitration.

- 15. <u>On 2 May 2019</u>, the Parties communicated their agreed amendments to the Procedural Calendar of the present arbitration as follows:
 - To extend the deadline for submission of Respondent's *Rejoinder and Reply on New Jurisdictional Objection* from 10 May 2019 to 24 May 2019;
 - To extend the deadline for submission of Claimants' *Surrejoinder on New Jurisdictional Objection* from 14 June 2019 to 28 June 2019; and
 - To advance the date for the *notification of witnesses and experts*, currently set for six weeks before the hearing, to 9 September 2019.
- 16. <u>On 3 May 2019</u>, the Tribunal confirmed and agreed with the Parties' amendments to the Procedural Calendar.

II. ORDER

17. Having reviewed and considered the Parties' correspondence and agreement to amend the Procedural Calendar – to which the Tribunal agreed – the Tribunal hereby orders as follows:

The Tribunal adopts the amended Procedural Calendar as enclosed to the present Procedural Order No. 22 as Annex A.
