I write on behalf of the Tribunal.

The Tribunal acknowledges receipt of the Claimant's Response to Canada's Motion on Valuation Data, dated 28 August 2020.

Having considered the Parties' respective submissions on Canada's request, the Tribunal is of the view that it requires further information in order to make its decision and invites the Respondent to explain more fully why the information that they seek is both (i) not in the schedules in Section 10 and the figures in Appendix B of the Deloitte Expert Report (CER-1); and (ii) cannot be deduced from the information the Claimant has provided in its submission of 7 August 2020, including the Memorial, the Deloitte Expert Report, and accompanying documents. The Respondent is requested to provide this information by no later than Friday, [4 September 2020](#). Thereafter, the Claimant may submit any comments it may wish to make on the Respondent's submission by [Friday, 11 September 2020](#).
