

## FIRST WITNESS STATEMENT OF PARTHENYA TAIYANIDES

- 1) My name is Parthenya Taiyanides. I am a paralegal at the Reed Smith, LLP, located at 599 Lexington Ave, New York, NY 10022. I have worked at Reed Smith, LLP as a paralegal since October of 2016.
- 2) As I describe more fully below, on July 27, 2020, I accessed the website of the Permanent Court of Arbitration (“PCA”) and viewed certain witness testimony, presentations, and arguments that are publically available on that website in connection with the Mesa Power Group LLC v. Government of Canada arbitration (PCA Case No. 2012-17) (the “Mesa Arbitration”). In particular, I viewed the witness testimony of witnesses Sue Lo, Bob Chow, Rick Jennings, Jim MacDougall and Shawn Cronkwright. I viewed the expert witness evidence of Seabron Adamson, and the valuation experts from both sides. I was not a part of the legal team in the Mesa Arbitration.
- 3) I also viewed the Day 1 and Day 6 videos. In the Day 1 videos, I was able to view the opening statements and view the opening presentation slides of both Canada and the Investor. In the Day 6 videos, I was able to view the closing statements and view the closing presentation slides of both Canada and the Investor (subject to the exceptions I note below). In short, I viewed the opening statements in their entirety and the closing statement of Canada in its entirety. When I viewed the Day 6 Part 1 video (part 1 of the Investor’s closing statement), there was a technical problem with the website that only allowed me to watch the first 29:54 minutes of this Day 6, Part 1 video. I was able to see the remainder of Day 6 in its entirety. I also had some difficulty with the Day 6 Part IV video as there was a typographical error in its posted name on the website – but following the standard naming conventions for all the other videos, I was able to see this video as well by changing the numeral 5 to 4 in the address.
- 4) While I have included specific links to the video I reviewed below, the video I viewed can also be accessed through the “Video” section pertaining to the Mesa Arbitration, available at <https://pca-cpa.org/en/cases/51/>.
- 5) As I viewed that testimony and proceedings from the public PCA website, I also had a copy of the corresponding public hearing transcripts issued in that Mesa Arbitration. While I have included specific links to the transcripts I reviewed below, those transcripts can also be accessed through the “transcript” section pertaining to the Mesa Arbitration, available at <https://pca-cpa.org/en/cases/51/>. As a result, I was able to confirm that I heard and viewed testimony at the Mesa hearing via video on the PCA website that was redacted from the public hearing transcripts.


## F. Closing Arguments
